Students taking courses at another versity must obtain a minimum grade of B- (65%) if the course is to be credited their McGill degree. 8 Postdoctoral Research

8.1 Postdocs

Postdocs are recent graduates with a Ph.D. ovælqut (i.e., Medical Specialist Diploma) erged by a member of the Weisity's academic stafincluding Adjunct Professors, to assist him/her in research.

i. Postdoctoral status will be recognized by the versity in accordance with Quebec viruoial regulations. Persons may only be issered with postdoctoral status for a period of up to versity from the date the vere avarded a Ph.D. or equalent degree. Time allocated to parental or health leave is added to this period of time. Leas for other reasons, including oation leave, do not set the term. Postdocs must do research under the supervision of a McGill profess, and under the discipline in which training is being provided and with the abilities to full responsibilities as a supervisor of the research and as a mentor for versity are expected to be engged primarily in research with minimal teaching or other responsibilities.

2. Registration

- i. Postdocs must begisstered annually with the **Une**rsity through Enrolment Services. Initialtistration will require an original or notarized scopf the Ph.D. diploma. Restration will be limited to persons who ful®l the de®nitionvalaond for whom there is an assurance of appropriate funding and where the unit can proble assurance of the necessary resources to permit postdoctoral education.
- ii. Upon registration, the Postdoc will be eligible for a Weisity identity card issued by Enrolment Services.
- 3. Appointment, Pay, Agreement of Conditions
 - i. Appointments may not eeed your reistration eligibility status.
 - ii. In order to be registered as a Postdoc, you must be assured of @nancial support other than from personal means during your stay are Neit Gill Uni equivalent to the minimal stipend requirement set by the vertain in accordance with guidelines issued by federal and pair research granting agencies There are no procions for paid parental lea unless this is stipulated in the processing agencies.
